
03. Nominated officers must not proceed without acceptance of nomination.

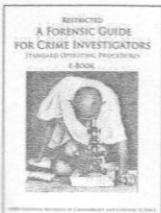
